Spinal Screening (4th-8th Grade Only)

____ Yes, I give permission for my child to have a spinal screening at school.

Sharing of Health Information

____ Yes, I give permission for my child's health information to be shared by school health personnel with school employees directly involved with my child.

Dental Screening (Kindergarten and 9th Grade Only)

____ Yes, I give permission for my child to have a dental screen at school.

____ Yes, I give my permission for my child to view, "The Always Changing Always Growing" puberty movie.

Internet

____ Yes, I give permission for my child to have access to electronic communication known as the Internet and agree to abide by the school board policies and procedures outlining this access, as defined in the student handbook.

Media Release

____ Yes, I give my permission for my child to be photographed, video taped, and/or audio taped for school related purposes and activities. I also give permission for my child to be named, shown or pictured in the newspaper, on the radio or television in school related features. Insect Repellent (Preschool Only)

____ Yes, I give permission for my child/children to have sunscreen applied by school personnel if needed during outdoor school related activities if supplied by me.

Internet Filtering

____ Yes, I understand that inappropriate web content is filtered on all devices connected to the school's network, however, inappropriate content is not filtered when the devices are off the school's network. It is my responsibility as a parent and/or guardian to ensure school equipment are being used appropriately when off school grounds.

Computer Repair (Chromebook Program Grades 4th-12th)

____ Yes, I would like to participate in the damage and loss program at a cost of \$25 for the school year. This covers the Chromebook loaned to my child against unintentional damage or loss at 100% with no deductible or copay. I understand if I decline this coverage I will be responsible for 100% of the cost of parts for my child's Chromebook, plus the labor required to fix the damage at a rate of \$20 per hour, should damage or loss occur. Total value will be determined by the District at the time of damage or loss. I understand I have 7 calendar days from the date I register my child to participate in the damage and loss program, after that time I am no longer eligible to participate.

Chromebook Program Permission (Grades 4th-12th)

____ Yes, I understand one Google Chromebook, charger, and case are being loaned to my student and are in good working order. It is my student's responsibility to care for the equipment and ensure that it is retained in a safe environment. This equipment is, and at all time remains, the property of Denison Community Schools of Denison, Iowa, and is herewith lent to my student for educational purposes only for the academic school year. My student may not deface or destroy this property in any way. Inappropriate use of the machine may result in him/her losing his/her right to use this computer. The equipment will be returned to the school when requested by Denison Community Schools, or sooner, if the he/she withdraws from Denison Community Schools prior to the end of the school year. They may only use the technology for non-commercial purposes, in accordance with the District's policies and rules, the District's Code of Conduct, as well as, local, state, and federal statutes. My student may not install or use any software other than software owned or approved by the District and made available to him/her in accordance with this agreement. One user account with specific privileges and capabilities has been set up on the Google Chromebook for the exclusive use of my student to which it has been assigned. My student agrees to make no attempts to change or allow others to change the privileges and capabilities of this user account, make no attempts to add, delete, access, or modify other user accounts on the Google Chromebook and on any school-owned computer, take no action that would interfere with the efficient, academic use of the network. Identification and inventory labels/tags have been placed on the Google Chromebook. These labels/tags are not to be removed or modified. Additional stickers, labels, tags, or markings are not to be added to the Google Chromebook. A Google Apps for Education account is available for each Student/Borrower to use for appropriate academic communication with other students and staff members. Iowa statute allows the District to obtain reimbursement from, or on behalf of, students for any damage to, loss of, or failure to return school property. The full cost of the Google Chromebook is approximately \$300.
