Superintendent Report

- a) **Dual Language Update-**Director of School Improvement Heather Langenfeld gave a brief presentation on how the Dual Language Program will be implemented and several of the benefits and advantages the program, and a timeline of implementation from now until June of 2018.
- b) **First Reading of 201, 202.3, and the 700, 800, and 900 Series of School Board Policies** Motion by Andersen, Lambert to approve the first reading of the 201, 202.3, and the 700, 800, and 900 series of school board policies.  - c) Second Reading of Board Policies 407.3 Licensed Employee Retirement and 413.2 Support Staff Retirement

Brief discussion on early retirement policy for the 2017-18 school year. The years of experience requirement would change and the dollar amount per sick day would change at certain levels and the \$100 minimum benefit would be removed.

Years of Experience:

10-14 years - Amount Paid/Unused Sick Leave is \$1.25 (2017-2018 school year only)

15-19 years - Amount Paid/Unused Sick Leave is \$1.50 (2017-2018 school year only)

20-24 years - Amount Paid/Unused Sick Leave is \$2.00

25-29 years - Amount Paid/Unused Sick Leave is \$2.50

30 years or more - Amount Paid/Unused Sick Leave is \$3.00

- f) **Presentation of Preliminary Budget and District Financial Health Information-**Business Manager Larson gave a presentation on the 2018-2019 Preliminary Budget and Financial Comparison Data for FY17. He noted enrollment is up 37 students on certified count. The District's solvency ratio is within the recommended target range at 12.64%. All indicators show the District is in sound financial health.
- g) Administrator Updates –Broadway Elementary Principal Trevor Urich shared STAR Assessments start January 16, 2018 and Iowa Assessments will take place in February. Denison Elementary Principal Chris Schulz commented on the positive Dual Language meeting that took place in the building. He shared the technology work that Darin Johnson and Stephanie Gierstorf have been doing with the Tech Club for 3rd graders that included coding, graphics and some work with drones. Middle School Principal Patti Ryan shared that the Middle School dance was a great success. The Middle School staff is re-aligning homerooms based on progress monitoring. Middle School Instructor Judd Nielsen has started a Chess Club and has 27 students that will participate in a tournament in May. High School Principal Dave Wiebers shared that Iowa Assessments will take place in February and the Senior Class will go to the Iowa State Capitol at the same time. He noted the high school will host a Career Day on January 24th with a number of speakers from the local area and region.
